This November, voters in Chaves County will be asked to invest in the state's public colleges, universities and specialty schools. General Obligation Bond D (referred to as GO Bond D) is asking voters to approve more than \$128 million for needed renovations, upgrades and improvements to colleges and universities statewide. If approved by voters statewide, GO Bond D will not increase property taxes.

In Chaves County, approval of Bond D will mean an allocation of \$3 million for ENMU-Roswell, which will fund needed renovations to the Automotive Technology/Welding facility on campus. NMMI would receive \$8.5 million for needed renovations to the Barracks Sink rooms and JRT/VMV/Hinkle Hall.

Also, passage of Bond D is estimated to create approximately 112 jobs in construction, architecture and related fields, adding to our community's economic development and gross receipts tax revenue.

For many of New Mexico's colleges and universities, including ENMU-Roswell, GO Bond D is the only source of funding that allows us to re-invest and modernize facilities we already have, improve safety and technology, and boost degree and certificate programs that give our students the knowledge and skills they need to pursue high-paying, in-demand careers.

These voter-approved funds are a crucial to ensuring our schools remain competitive and are able to attract the best and brightest students and faculty as well as provide a quality education and a safe learning environment. GO Bond D will not only invest more than \$128 million into our state's colleges, universities and specialty schools, but will do this without increasing the burden on New Mexico's taxpayers.

Absentee voting will be open from

October 9 - November 2. Early voting will be open from October 20 - November 3. Election Day is Tuesday, November 6, with polls open for in-person voting from 7 a.m.-7 p.m.

ASSIST. PROFESSOR OF BIOLOGY



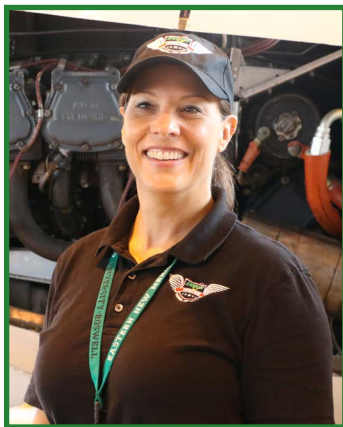
Dr. Lynne Cary

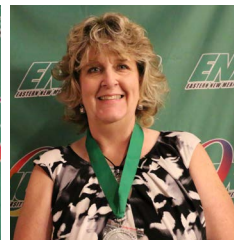

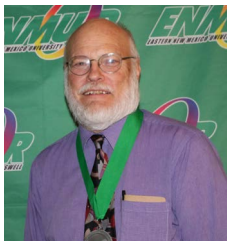

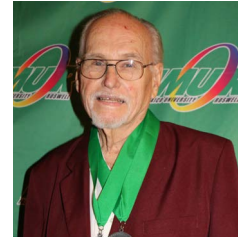

Try It Track It Project

ONE STOP CENTER

DEFINE THE PROBLEM:

Looking at how many visits each student made in the One Stop Center. Data showed that more than 77.09% of visits were duplicated. The reasons included were turning in forms that were requested during their first visit and completing financial aid and admission & records requirements.

HOW WAS IT ADDRESSED?

Directors and assistant directors in affected areas were brought together to develop a plan to more efficiently serve students in fewer visits by simplifying the process. Directors and Assistant Directors met and made the decision to provide staff with more clear guidance. A pre-screen checklist was formed to ensure staff went through the checklist with each student to ensure they were ready before seeing an advisor.

WAS IT SUCCESSFUL?

The project was successful. Between spring 2014 and spring 2018 the percentage of visits that were duplicates reduced from 77.09% to 57.86%. This process decreased the complaints from students about the staff not providing all the information the student needed.

DATA COLLECTED:

Data was collected from the Who's Next student visit tracking system. The data showed a decrease in duplicate visits of nearly 20% from 2014-2018 which supports the intent to assist students in fewer visits and increase efficiency. The One Stop Center intends to continue utilizing the checklist and attempt to find a digital solution that will make the process even more efficient and trackable.

WHAT DID WE LEARN?

Prior to fall 2017 the One Stop Center added a special section to the checklist which alerts staff to check each student for eligibility for the Gear Up scholarship as they had an incoming GearUP cohort. This was continued in Fall 2018 as a second GearUP cohort arrived on campus. They plan to continue modifying the checklist as special circumstances or populations join the campus community to ensure they are serving the students as efficiently as possible. They also found that providing a written guide for staff improves their interactions with students because it serves as a template to check dates and drive the conversation toward its end goal.
