I. **Dr. Shawn Powell**

- a. Introductions were shared with Dr. Stephen Grieco, new Dean for the School of Arts and Sciences.
- b. If you have any capital project requests and have not submitted them, please email those requests to Dr. Powell.
- c. Twenty-six states filed injunctions against implementing the new Title IX regulations, along with multiple organizations in those states. ENMU-Roswell, NM State, Central New Mexico College, and Clovis Community College are named in the injunction. If a student from a given campus is a member of one of these organizations, then that campus is prohibited from implementing those new Title IX regulations. We are still focusing on our Title IX work. If you should encounter anything that is Title IX related, please continue to do what we have been doing as far as Title IX.
- d. Gerald Shumaker, an ENMU-R alumnus, has left funds from his estate to ENMU-R and the check was received yesterday. The plan is to have a pavilion erected and named after Mr. Shumaker with these funds. A Facilities Designation Committee has unanimously agreed to name the outdoor pavilion in memory of Gerald Shumaker. The naming request will go to the Community College Board next week and then the Board of Regents next month for approval.
- e. Please review the Five-Year Plan and let Dr. Powell or Leona know if you have any suggestions for additions/changes to the plan as written.
- f. Martha has been busy getting flyers and announcements out along with videos regarding the GO Bond. Dr. Powell and Martha have been doing community projects and presentations and visiting local school boards. RISD, Dexter and Hagerman have all signed resolutions in support of the GO Bond. Will be meeting with Lake Arthur and Artesia next week to ask that they sign resolutions in support of the bond. We are trying to get this out to the community. The city is doing a resolution next week during the regular Thursday meeting. The ask is \$5.3 million for the AMT building expansion.
- g. Final documents have been received for the cost estimates for walkways and sprinkler systems. Now starting the approval process. Friday, we will request approval from Board of Regents. By the time we get through approval process, it will be January start time. Hal Barnette, estimates it will be 6-8 months for walkways and sprinkler system and will be 7-9 months to complete.

- h. Waide Construction is doing the Nursing Expansion project. Demolition will start October-November timeframe with a promise to have it complete by August 1, 2025.
- i. ITC Roof Replacement is with architects now. Once their part is complete, we will move forward and will most likely be January before project is started.
- j. Devin gave an update on enrollment: increase of 3%, currently at 2088 students. First time freshmen up by approximately 200 students. Semester class hours are showing a 7% increase over last year. We will be looking at our continuing student number going forward. Lost about 65 students from last fall.
- k. Director of Child Development Center and Access Grant Director are priorities to fill from the list on the handout of open positions. We take over the Child Development Center on November 25, 2025. Access Grant will be active in October.

- 3. Jacob will work with Martha to get a message out to students on social media. Martha will send message to canvas and send out email notification. Devin can send text to all students through the CRM. Jacob will get out on video monitors. Message will be sent to Deans to share with their schools.
